Re: Notice in accordance with Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations

Dear Mr. Dowling,

I am to refer to the above referenced application for a waste licence relating to a facility at Waterford Utility Services (Waste Disposal) Ltd, Six Cross Roads, Carriganard, Butlerstown, Co. Waterford. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 COMPLIANCE REQUIREMENTS

1. Section B.3 of the application states that planning permission is not required for the development proposals. Please provide reasons why planning permission is not required and include any relevant correspondence from the Planning Authority.
2. Please provide a copy of the most recent planning permission including a copy of all conditions.
3. Please provide correspondence from the Planning Authority confirming that an EIA is not required for the proposals.



4. Submit a site drainage plan showing storm and foul systems, location of gullies, oil interceptor(s), tanks and locations of emission points and proposed sewer connection etc. Provide a written description of both systems.


Your reply to this notice should include a revised non-technical summary, which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one original plus two copies within **one month** of the date of this notice. In addition please submit two copies of the requested information in electronic searchable PDF format on a CD-ROM to the Agency. Please note that all maps/drawings should not exceed A3 in size.
