1. INTRODUCTION

This report presents the response by Nurendale Ltd trading as PANDA Waste Services Ltd (PANDA), Rathdrinagh, Beauparc, Navan, County Meath, to the Agency's Notice issued under Article 14(2)(b)(ii) of the Waste Management Licensing Regulations on 26th July 2007, in relation to the application for a review of Waste Licence, Application Register No. W0140-03, for a non-hazardous materials recovery and transfer facility at Rathdrinagh, Beauparc, Navan, Co. Meath.

Section 2 contains the responses to the Agency's requests. For ease of interpretation each of the requests are presented in italics followed by PANDA's response.

2. ARTICLE 12 COMPLIANCE REQUIREMENTS

1. In the licence review application submitted to the Agency, reference is made on page 8 to the landfilling of non-recyclable residual waste. Please provide details of the location of the landfill(s) in question.

Non-recyclable residual waste is sent to Knockharley Landfill, County Meath (W0146-01), Whiteriver Landfill, County Louth (W0060-01), KTK Landfill, County Kildare (W0081-03), Balleally Landfill, County Dublin (W0009-02) and Arthurstown Landfill, County Kildare(W0004-03).

2. In response to Article 12 (1)(g), the application states that the recycling of end- of-life tyres and end-of-life vehicles is proposed for the site. Please provide details of the existing or proposed infrastructure to cater for the handling of this waste stream.

End-of-life vehicles are not currently accepted at the facility and there is no specific infrastructure in place for its storage or processing. It is not expected that end-of-life vehicles will be accepted at the facility in the near term and therefore specific proposals have not yet been developed. PANDA does however require the flexibility to accept this waste type in the future subject to market conditions. Prior to the acceptance of this waste stream PANDA will submit acceptance, storage and handling proposals to the Agency for their approval, which will form specified engineering works for this activity.

Small volumes of end-of-life tyres (EWC 16 01 03) are accepted at the facility, usually as part of the domestic and commercial skip hire business where 1 or 2 tyres may be contained within the skip (approximately 30 tonnes in 2006). In this instance the tyres are stockpiled in high sided roll on roll off skips and sent for recovery to Crumb Rubber Ireland Ltd, Mooretown, Dromiskin, Dundalk County Louth (WP 033/02).

3. The application states that planning permission (file no. SA 60656) for the proposed additions to the site infrastructure is currently under consideration with the Planning Department of Meath County Council. Please provide the Agency with details of the planning application and the decision of the Planning Department at your earliest convenience.

PANDA submitted an application for planning permission to Meath County Council for the construction of the new materials processing building, a new skip repair building, the provision of a reed bed surface water treatment area and ancillary site works. The details of

the proposed infrastructure are shown on Drawing No. V130_A_12 submitted with the Licence Review Application.

On 20th February 2007 the Council requested further information in relation to the application, which was responded to by PANDA on the 17th August 2007. PANDA will inform the Agency as soon as a decision is issued by the Meath County Council.
