Dear Mr. Burke

I refer to your letter received 16 August 2007 in accordance with Section 49 of the Waste Management Acts, 1996 to 2005 seeking an extension of the three year time period specified.

I am to advise that the Agency has considered your request and decided in accordance with Section 49(2)(b) of the Acts, to grant an extension for a period of three years. The period specified will now end on 17 November 2010. Where the activity to which the waste licence relates has not been substantially commenced, the licence shall cease to have effect on the expiry of this period. Notwithstanding this the licensee may make an application to the Agency to extend the period specified in accordance with Section 49(2)(b) before the 17 November 2010.

This decision was made having regard to the reasons outlined in your letter dated 16 August 2007.
