Dear Shay

A total of 111 landfills have been licensed by the Agency to date, further details on all landfills licensed by the Agency are available on our website including copies of licences, related documents and inspectors reports. The degree to which landfills are engineered will be detailed in the individual licences and inspectors reports.

I have attached a list of licensed landfills by Region which are either currently accepting waste or may be accepting waste in the future. While some of the older landfills on this list were not historically fully engineered any waste accepted at these landfills, following licensing by the Agency, may only be landfilled to engineered cells. All new landfills on the list are required to be fully engineered. Some of the older landfills on the list are in the rehabilitation phase and are accepting only inert waste for recovery purposes.
