APPLICATION FOR A REVIEW OF A WASTE LICENCE

Decision and Reasons for Decision

Decision & Reasons for the Decision

On the basis of the information before it, the Environmental Protection Agency (the Agency) pursuant to its powers under Section 46(8) of the Waste Management Acts 1996 to 2005 hereby refuses to grant a revised licence to South East Recycling Company Limited to carry on the expanded waste activities, the scale and details of which are set out in the waste licence review application Register Number W0111-03, at Carrigbawn, Pembrokestown, County Wexford.

In reaching this decision the Environmental Protection Agency has considered the application, supporting documentation and objection received from the applicant, all submissions received from other parties and the reports of its inspectors.

Reasons for the Decision

- 1. The applicant has not demonstrated to the satisfaction of the Agency, that the expansion in operations applied for in the licence application review will be carried out in accordance with the conditions of a revised licence if granted.
- 2. The Agency is not satisfied, based on the current infrastructure at the facility and non compliance with requirements of the existing licence to provide the necessary infrastructure to carry on the waste activities, that the best available technologies as described in Section 40(4)(c) of the Waste Management Acts, 1996-2005 will be used in the expanded waste activities.
- 3. The Agency is not satisfied that the applicant will manage an increased waste input and ensure that the necessary protective measures are taken so that operations at the facility will not cause or lead to environmental pollution.

Part I Schedule of Activities Refused

Waste Disposal Activities, in accordance with the Third Schedule of the Waste Management Acts 1996 to 2005, the scale and details of which are set out in the waste licence review application Register No: W0111-03.

Class 11.	Blending or mixture prior to submission to any activity referred to in a preceding paragraph of this Schedule.
Class 12.	Repackaging prior to submission to any activity referred to in a preceding paragraph of this Schedule.
Class 13.	Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced.

Waste Recovery Activities, in accordance with the Fourth Schedule of the Waste Management Acts 1996 to 2005, the scale and details of which are set out in the waste licence review application Register No: W0111-03.

Class 2.	Recycling or reclamation of organic substances, which are not used as solvents (including composting and other biological processes).
Class 3.	Recycling or reclamation of metals and metal compounds.
Class 4.	Recycling or reclamation of other inorganic materials.
Class 13.	Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced.
