Oxigen Environmental Ltd. wishes to apply to the Agency for a technical amendment to Condition 1.7 of the above license issued to Sean Rooney Ltd trading as Bambi Bins and Wheelbin Services Ltd.

Currently condition 1.7.1 reads 'Waste shallonly be accepted at the facility between the hours of 5:30am and 9:30pm Monday of Saturday inclusive' and we are requesting that this be amended to read 'Waste shall only be accepted at the facility between the hours of 5:30am and 12:00am (Midnight) Monday to Saturday inclusive'

Condition 1.7.2 reads "The facility shall only be operated during the hours of 5:00a.m. and 9:30 p.m. Monday to Saturday inclusive" and Oxigen is requesting that this be amended to read "the facility shall only be operated during the hours of 5:00 a.m. and 12:30 a.m. Monday to Saturday inclusive"

The reason for this request is to ensure that we can provide an increased recycling service to all of our domestic customers by providing them with a brown bin collection for organic waste and also to increase their number of green bin dry recycling collections. We are also facing demands from commercial customers for increased collections. Due to traffic restrictions in both Drogheda and Dundalk more and more of our commercial customers are demanding that we collect in the evenings.

If this technical amendment is agreed it is proposed to collect material as usual and bulk up the material at the facility. Material will be tipped and loaded straight away into ejector trailers and any putrescible material will then be stored in closed ejector trailers, indoors, until it can be removed to the landfill at the first available opportunity, in compliance with Condition 7.5 of the Licence.



All tipping and bulking of material will occur indoors with all shed doors remaining closed so as not to give rise to odour or noise.

Should C&D material be accepted after 9p.m. the skip will be parked up and tipped the following morning so as not to give rise to noise nuisance. All other Conditions of License W0144-01 will be met.

We hope that the Agency will look favourably on this request. Trusting this is satisfactory, we look forward to a response from the Agency.
