4. **Recommended Decision on an Application for a Waste Licence**

Licensee: **Waterford Utility Services
(Waste Disposal) Limited
Six Cross Roads
Carriganard
Butlerstown
Co Waterford**

Register of Licence No: **W0116-02**

The Directors considered a recommendation from the Office of Climate, Licensing & Resource Use that the Agency approve the recommended decision to grant a Waste licence. The following documentation was submitted: Recommended Decision and summary report of the Inspector. The Directors noted that this is a review of Waste Licence No W0116-01, issued by the Agency on 5 May 2000.

A copy of the licence application was tabled.

P Larkin gave a verbal presentation.

Inspector's Report

The Directors noted the Inspector's Report.

Under the Fit & Proper Person Assessment, the Directors noted that the historical compliance issues were while under the ownership of a different company.

Recommended Decision

Introduction

Amend 2nd sentence, paragraph 2 to read: the licence allows up to 70,000 tonnes per annum of waste to be processed at the facility *contingent upon specified infrastructure being installed*.

Glossary

Amend Putrescible Waste definition to read: Waste *that* is readily biodegradable, such as vegetable matter, green waste etc.

Condition

3.8.2 Amend to read: Within *one* month from the date of grant of this licence, the licensee shall provide a report for the agreement of the Agency detailing *their programme to meet the 35,000 tonnes/annum limit and* the duty and standby capacity in tonnes per day, of all waste handling and processing equipment to be used at the facility. These capacities shall be based on the licensed waste intake, as per *Schedule A: Limitations*, of this licence.

- 3.12.1 Amend 2nd sentence to read: The licensee shall submit, for agreement by the Agency, details of the proposed measures within *one* month of date of grant of licence.
- 3.12.1(ii) Amend to read: Unless otherwise agreed by the Agency, all buildings processing putrescible waste shall be maintained at negative air pressure, with ventilated gases being subject to treatment as *approved* by the Agency.
- 6.18 Amend to read: The licensee shall, within six months of the date of grant of this licence, develop and establish a Data Management System for collation, archiving, assessing and graphically presenting the environmental monitoring data, *and in particular the requirements of Condition 11.9*, generated as a result of this licence.
- 9.4.1 Amend 1st sentence to read: In the event of a breakdown of equipment or any other occurrence which results in the close of the transfer station building, *or as directed by the Agency*, any waste arriving fully operational status.
- 12.1.1 Clarify amount of annual contribution payable to the Agency and amend if necessary.

Schedule

- A.2 Amend Note 3 to read: The licensee shall not accept greater than *35,000* tonnes per annum until the infrastructure referred to in this licence is in place.

The Directors approved the recommended decision to grant a licence, as modified, to Waterford Utility Services (Waste Disposal) Limited for their facility at Six Cross Roads, Carriganard, Butlerstown, Co Waterford, Register of Licence No W0116-02, subject to the conditions as set out in the licence document.
