NOTICE OF THE MAKING OF MALLOW SPECIAL  
LOCAL AREA PLAN 2007**

Notice is hereby given, pursuant to Section 20(3) of the Planning & Development Acts, 2000 as amended by Section 9 of the Planning & Development (Amendment) Act, 2002, that Cork County Council and Mallow Town Council, being the Planning Authorities for the town of Mallow and environs, have adopted the Mallow Special Local Area Plan in June 2007. This plan is now available in its final published format.

The purpose of the Plan is to put in place a unified development framework for the town of Mallow, looking forward to the year 2020 and taking into account the town's hub status arising from the National Spatial Strategy.

An Environmental Impact Statement summarising how environmental considerations have been integrated into the plan has also been prepared in accordance with the Planning & Development (Strategic Environmental Assessment) Regulations 2004.

Please note that in order to facilitate the making of the Mallow Special Local Area Plan 2007 it was also necessary to vary the Mallow Town Development Plan 2004 and to amend the Mallow Electoral Area Local Area Plan 2005.
