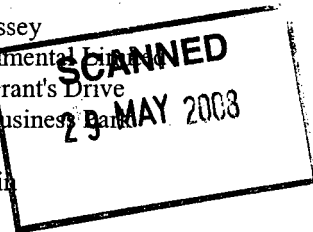

In accordance with Article 34 of the Waste Management (Licensing) Regulations, the Agency hereby notifies you of its decision to grant a revised waste licence to Rilta Environmental Ltd (formerly known as SITA Environmental Ltd), subject to conditions, in respect of a facility at Rilta Environmental Limited, Block 402, Grant's Drive, Greenogue Business Park, Rathcoole, County Dublin. Please find accompanying a copy of the Agency's decision.

This decision was made following consideration of the objection and technical committee report to the Agency's proposed decision in accordance with the Waste Management Acts, 1996 to 2007 and related Regulations.
