This Waste Licence Application is for a proposed Construction, Demolition & Excavation Waste Recovery Facility (C,D&E Facility) together with the associated management and restoration of waste lagoons, ponds and other lands covered by PPC Licence Register No. P0389-01. The Application Site area is ca. 29.0 ha. It is proposed to accept 300,000 tonnes per annum of nonhazardous (inert) construction, demolition and excavation wastes for a period of up to 10 years.
