re: Notice in accordance with Article 8 of the Waste Management (Licensing) Regulations

Dear Ms Doyle:

I am to refer to the above referenced application for a waste licence relating to a facility at Molaisin Compost Ltd, Kilmolash, Cappaquin, Co. Waterford. I am directed to advise you of a failure of compliance with Article 7 of the relevant Waste Management (Licensing) Regulations. The notice as erected or fixed on the facility or premises contravenes Article 6 c of the regulations - Class or classes of activity should be the same as the newspaper advertisement.

The Agency therefore requires you, in accordance with Article 8 of the regulations, to

Erect a revised site notice to be displayed for a 2 month period to ensure conformity with the newspaper advertisement.

The Agency further requires you to submit the following evidence in relation to compliance with the above requirement:

A copy and a photograph (in situ) of the revised site notice.

The evidence requested should be submitted within 1 week of the date of this notice, in the form of a one original plus two copies. In addition submit two copies in electronic searchable PDF format on a CD-ROM to the Agency. Please note that all drawings/maps should not exceed A3 in size.
