### TRANSFER OF A WASTE LICENCE

Decision of the Agency, under Section 47(5) of the Waste Management Acts, 1996 to 2008

Waste Licence Register No: W0129-02

The Agency, in exercise of the powers conferred on it by the Waste Management Acts, 1996 to 2008, for the reasons hereinafter set out, hereby transfers waste licence register number W0129-02 from Murphy Concrete Manufacturing Limited, Hollywood Great, Nags Head, The Naul, County Dublin, to Murphy Environmental Hollywood Limited, Hollywood Great, Nag's Head, The Naul, County Dublin. Waste Licence Register No W0129-02 licenses the carrying on of the waste activities set out below at Murphy Concrete Manufacturing Limited, Hollywood Great, Nags Head, The Naul, County Dublin subject to twelve Conditions, as set out in the waste licence.

## Licensed Waste Disposal Activities in accordance with the Third Schedule to the Waste Management Acts, 1996 to 2008

Class 1.	Deposit on, in or under land (including landfill).
Class 5.	Specially engineered landfill, including placement into lined discrete cells, which are capped and isolated from one another and the environment.
Class 13.	Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced.

# Licensed Waste Disposal Activities in accordance with the Fourth Schedule to the Waste Management Acts, 1996 to 2008

Class 3.	Recycling or reclamation of metals and metal compounds.
Class 4.	Recycling or reclamation of other inorganic materials.
Class 13.	Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced.



In accordance with Section 47(6) of the Acts, Murphy Environmental Hollywood Limited is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, they may arise.

### REASONS FOR THE DECISION

Pursuant to Section 47(5)(a) of the Acts, the Agency is satisfied, on the basis of the information available, that Murphy Environmental Hollywood Limited is entitled to be regarded as a fit and proper person to be granted a like waste licence. Pursuant to Section 47(5)(b) of the Acts, the Agency is satisfied, on the basis of the information available, that Murphy Environmental Hollywood Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the report of its inspector.
