7. **Recommended Decision on an Application for a Waste Licence**

*Licensee:* **Greenstar Ltd.**

**Clavass**

**Enniscorthy**

**Co. Wexford**

*Register of Licence No:* **W0241-01**

The Directors considered a recommendation from the Office of Climate, Licensing and Resource Use that the Agency approve the Recommended Decision to grant a Waste licence. The following documentation was submitted: recommended decision; one Third Party submission and summary report of the Inspector.

A copy of the licence application was tabled

**Inspector's Report**

The Directors noted the Inspector's Report.

**Recommended Decision**

*Introduction*

Amend 3<sup>rd</sup> sentence of 1<sup>st</sup> paragraph to read: The licensee *anticipates the acceptance of 60,000 tonnes in the first year and this will increase over the following seven years to 90,000 tonnes per annum.*

Delete the words *in addition* in the 5<sup>th</sup> paragraph to read: When the site is operating at maximum capacity there will be 15 full time staff and up to 40 drivers.

*Condition*

2.2.2.2 Amend to read: The licensee shall prepare ...the use of cleaner technology *and the prevention, reduction and minimisation of waste for disposal.* The schedule shall include time frames for the achievement of set targets and shall address a five-year period as a minimum. *In relation to waste recovery the schedule shall include an initial waste recovery target of waste throughput, as well as time frames for achieving higher recovery targets.* The schedule shall be reviewed annually...Annual Environmental Report (AER).

3.23.4 Insert new condition 3.23.4 to read: *The Licensee shall submit to the Agency for its approval, the proposed design for the negative air pressure system and odour abatement system.*

3.25 Clarify storm water run off/soak pit.

11.15 Reword as follows:

## Waste Recovery Reports

*The licensee shall as part of the Annual Environmental Report for the site submit a report on the contribution by this facility to the achievement of the waste recovery objectives stated in Condition 2.2.2.2 and as otherwise may be stated in National and European Union waste policies and shall, as a minimum, include tonnages of the following:*

- (i) the recovery of metals;*
- (ii) the recovery of C & D derived waste materials;*
- (iii) the recovery/treatment of biowaste;*
- (iv) the separation and recovery of other recyclable materials.*

### *Schedule D*

Amend 3<sup>rd</sup> sentence to read: 'Installation of dust/ odour *abatement* system'

The Directors approved the recommended determination to grant a licence, as modified, to Greenstar Limited for their facility at Clavass, Enniscorthy, Co Wexford, Register of Licence No W0241-01, subject to the conditions as set out in the licence document
