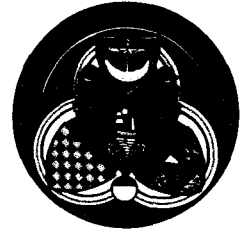

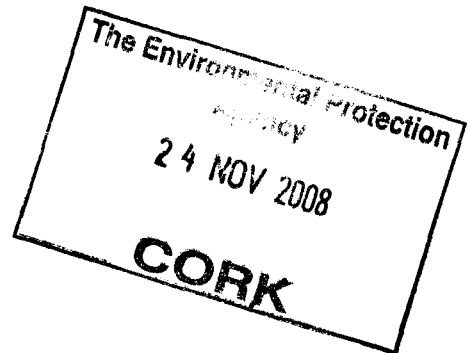
I hereby confirm that the site notices for both plants were re-erected at the locations specified in the licence applications.

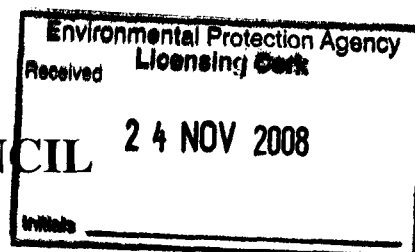

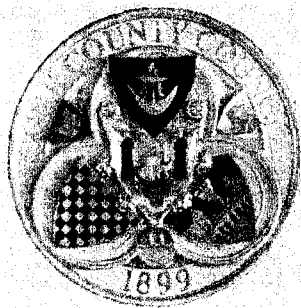
