re: Baleally Landfill – W0009-02 – Request for a Review

Dear Mr Daly,

I refer to the letter received by the Agency on 21st October 2008, from Mr. Larry O'Toole, RPS Consulting Engineers, and the accompanying report entitled 'Rogerstown Estuary Treated Leachate Discharge Modelling Report'. The letter requested a review of emission limit values (ELVs) for the discharge of treated leachate from Baleally Landfill to the Rogerstown Estuary. The Agency notes that Rogerstown Estuary is a designated Special Area of Conservation (SAC) and a Special Protection Area for birds (SPA). Following assessment of the information provided, it has been determined that a review of Waste Licence W0009-02 is required to fully consider your request.

In order to facilitate the licence review, I am to advise that a completed Waste Licence Application Form (available on www.epa.ie) together with the appropriate fee for a licence review in accordance with the second schedule of the Waste Management (Licensing) Regulations 2004, S.I. No. 395 of 2004, should be submitted to the Agency.

The Application Form shall be completed, as appropriate, to reflect the nature of the requested changes, including a detailed impact assessment of the requested discharge, emission monitoring, ambient monitoring etc., and any other changes agreed with the Office of Environmental Enforcement (OEE) since Waste Licence W0009-02 was issued. You are also requested to provide an update on the current and future landfill operations and waste activities at the civic amenity facility. Please include the following information in your submission, having regard to the current waste licence:

- Identify which licence conditions have been satisfied/completed;
- Identify which licence conditions remain outstanding;
- Identify any requested changes to the existing licence conditions;
- Summarise the changes agreed with the Office of Environmental Enforcement (OEE) since the licence was issued. Use OEE correspondence reference numbers, where available; and
- Provide an up-to-date register of environmental monitoring locations at the landfill.



Please supply the information in the form of a one signed original, one hard copy and two copies of all files in electronic searchable PDF format on CD-ROM. Please direct all correspondence in relation to this matter to the *Environmental Licensing Programme, Office of Climate, Licensing & Resource Use, Environmental Protection Agency, Headquarters, PO Box 3000, Johnstown Castle Estate, County Wexford.*
