

#### **RE: NOTIFICATION OF NON COMPLIANCE 115-1**

We refer to your recent site visit on 14 January 2004 and notification of non compliance dated 3 February 2004 and wish to respond as follows:

#### 1.0 Air Emissions A2

We have requested EURO environmental services to prepare a proposal on the upgrade and treatment of air emissions from A2. They have recommended a separation chamber together with an activated carbon bed. We attach their proposals

### 2.0 Groundwater Monitoring Point MWL

The groundwater monitoring point MWP has now been repaired.

#### 3.0 Storage of barrels in unbunded areas

All barrels containing liquid waste and solvent are now stored in certified bunded areas as per SOP 9A.23, PN15 and PN08.

#### 4.0 Labelling of barrels

All barrels are labelled in accordance with our labelling procedures as per our Environmental Management System.

We purchased the storage container from Chem Store who are suppliers of chemical storage housing. The unit is constructed of steel which is a non combustible material. Vents have been fitted at the bottom of the walls, 2 at the entrance and 2 at the rear. The floors and walls are sealed and the floor is fitted with a bunded section which meets the 110%/25% rule. The floors of the storage area have the same height as nearby buildings. The storage area is also fitted with steel doors which meet the minimum 30 minute fire rating. We have referred to the draft BAT reference document on emissions from storage dated July 2003.
