re: Notice in accordance with Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations

Dear Mr Hedigan,

I am to refer to the above referenced application for a waste licence relating to a facility at Clean (Ire) Refuse & Recycling Ltd, Ballinagun West, Cree, Co. Clare, Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 and Article 13 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

## ARTICLE 12 COMPLIANCE REQUIREMENTS

- Up-date tables E.1 (ii), E.1 (iii), F.1 and F.2, for proposed emission points.
- Quantify in terms of energy resources the information provided on energy, electricity, oil, and water etc. used on annual basis at the facility.
- Clarify the proposed source and nature of wood for use as a fuel in the **Biomass Recovery Plant**. Clarify, providing justification, whether EC Directive No. 76 of 2000 on the incineration of waste applies to your proposed use of wood as a fuel.
- Provide technical details and specifications (including cubic capacity) for the underground leachate tank proposed for the Biostabilisation plant.
- With regard to waste generated and accepted on-site, provide information on the quantity in tonnes produced and the reuse, recovery and/or disposal routes of each waste stream proposed, complete Table H.1 (i) and H.1 (ii)



- Clarify the class of silt/oil interceptors currently employed and/or proposed for the facility.
- Justify the requirement for storage of 60,000 litres of fuel oil. Clarify the bunding for this portable storage unit.

## **Article 13 Compliance Requirements**

- Clarify the proposed source and nature of wood for use as a fuel in the **Biomass Recovery Plant.** Clarify, providing justification, whether EC Directive No. 76 of 2000 on the incineration of waste applies to your proposed use of wood as a fuel.
- Clarify the types of wastes to be potentially accepted and treated at the Biostabilisation plant. Submit list of wastes referred to on page 48 of the EIS.
- Submit drawing No CL(IRL) WL-10 referred to on page 140 of EIS and omitted from attachment 2 of the EIS.
- Supply complete and comprehensive details of the end of life vehicles depollution process to be carried out on site. Supply details of the source and the treatment of the end of life vehicles on site and the destination of the depolluted parts.
- Confirm if the noise impacts of the End of Life Vehicle depollution process has been assessed (such as air bag deployment)
- Submit Drawing C(IRL) WL-06 (noise sensitive locations) referred to on page 168 of EIS and omitted from attachment 3 of EIS.
- Submit Appendix 1referred to on page 173 of EIS.
- Submit drawing C(IRL) WL-25 referred to on page 183 of EIS and omitted from attachment 3 of EIS.
- Clarify the class of silt/oil interceptors currently employed and/or proposed for the facility.

Your reply to this notice should include a revised non-technical summary (Application Form and EIS), which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one (1) original plus one (1) copy in hardcopy format within 4 weeks of the date of this notice. In addition submit sixteen (16) copies of the requested information to the Agency in electronic searchable PDF format on CD-ROM. Please note that all maps/drawings should not exceed A3 in size.
