This form is for the purpose of making an application for a Waste Water Discharge Licence under the Waste Water Discharge (Authorisation) Regulations, 2007 (S.I. No. 684 of 2007) or for the review of an existing Waste Water Discharge licence.

The Application Form **must** be completed in accordance with the instructions and guidance provided in the Waste Water Discharge Licensing Application Guidance Note. The Guidance Note gives an overview of Waste Water Licensing, outlines the licence application process (including the number of copies required) and specifies the information to be submitted as part of the application. The Guidance Note and application form are available to download from the Licensing page of the EPA's website at www.epa.ie.

A valid application for a Waste Water Discharge Licence must contain the information prescribed in the Waste Water Discharge (Authorisation) Regulations, 2007 (S.I. No. 684 of 2007). Regulation 16 of the Regulations sets out the statutory requirements for information to accompany a licence application. The application form is designed in such a way as to set out these questions in a structured manner and not necessarily in the order presented in the Regulations. In order to ensure a legally valid application in respect of Regulation 16 requirements, please complete the Regulation 16 Checklist provided in Annex 2.

PROCEDURES

The procedure for making and processing of applications for waste water discharge licences, and for the processing of reviews of such licences, appear in the Waste Water Discharge (Authorisation) Regulations, 2007 (S.I. No. 684 of 2007) and is summarised below. The application fees that shall accompany an application are listed in the Third Schedule to the Regulations.

Prior to submitting an application the applicant must publish in a newspaper circulating in the area, and erect at the point nearest to the waste water treatment plant concerned or, if no such plant exists, at a location nearest the primary discharge point, a notice of intention to apply. An applicant, not being the local authority in whose functional area the relevant waste water discharge, or discharges, to which the relevant application relates, takes place or is to take place, must also notify the relevant Local Authority, in writing, of their intention to apply.

An application for a licence must be submitted on the appropriate form (available from the Agency) with the correct fee, and should contain relevant supporting documentation as attachments. The application should be based on responses to the form and include supporting written text and the appropriate use of tables and drawings. Where point source emissions occur, a system of unique reference numbers should be used to denote each discharge point. These should be simple, logical, and traceable throughout the application.

The application form is divided into a number of sections of related information. The purpose of these divisions is to facilitate both the applicant and the Agency in the provision of the information and its assessment. Please adhere to the format as set out in the application form and clearly number each section and associated attachment, if applicable, accordingly. Attachments should be clearly numbered, titled and paginated and must contain the required information as set out in the application form. Non Technical Summary

Monaghan County Council is applying to the Environmental Protection Agency for a Waste Water Discharge Licence for the existing Waste Water Works at Rockcorry. The Waste Water Works comprises a network of gravity sewers and associated rising main and the wastewater treatment plant at Rockcorry. There is one Pumping Station called Crann Mor on the Rockcorry network at NGR 264342E 318895N. The plant is supervised/manned 7 days a weeks for a minimum of 2 hours, giving a minimum total of 14 hours a week.

The Waste Water Treatment Works design capacity is 1000 PE. The Works currently collects and treats domestic and trade effluent from a population equivalent of approximately 550PE. The treatment plant consists of the following treatment units: inlet Works, Septic Tanks, Inter Stage Pumping Station, High Rate Bio Filter, Clarifiers and Storm Water Holding Tank.

The Waste Water Treatment Plant treats in the region of 65 cubic metres of effluent every day and provides secondary treatment with nutrient removal (phosphorus reduction) for the effluent. The treated effluent has an average BOD concentration of 11.5mg/l and average suspended solids concentration of 16 mg/l. Average concentrations of nutrients are as follows; orthophosphate 5.79 mg/l (P), Total Phosphorus 1.93 mg/l (P) and Total Nitrogen 18.4 mg/l (N).

The outfall from the Rockcorry Waste Water Plant discharges to the an unnamed river in the Dromore River System at National Grid Reference 264465E, 318871N in the Townland of Boyher, Rockcorry Co. Monaghan Co. Monaghan The associated Waste Water Treatment Plant is located at 264476E 337664N also in the townland of Boyher, Rockcorry Co. Monaghan.

The river flows into Drumlona Lough and onto the Dromore River which is a tributary of the Erne System. The Dromore River is not designated sensitive under the UWWTR and the provision of nutrient reduction is not a legislative requirement under these regulations. The water body is at risk of failing to meet good status in 2015. The Drumlona Lough overall water quality status is strongly eutrophic with maximum chlorophyll of 58 (EPA, 2004). This eutrophic status is caused by enrichment of the water by nutrients (especially phosphorous and/or nitrogen compounds) causing accelerated growth in algae and other plant forms which causes an undesirable disturbance to the balance of organisms present in the water and the resultant quality of the water.

There is no hydrometric station or EPA monitoring station on the river or in the vicinity of the river to which the effluent discharges. The nearest flow monitoring station where data is available for the Dromore River is at Ashfield in County Cavan. The flow in the Dromore River at Rockcorry was estimated based on the estimated catchment area and using the flows from the Ashfield Station.

Monaghan County Councils upstream monitoring results indicate relatively good water quality in the river, with the average orthophosphate level recorded at 0.39 mg/l P, average ammonia levels of 0.03 mg/l NH₃-N, average BOD of 2.1 mg/l, average TP of 0.14mg/l, average TN of 1.69mg/l N and average suspended solids of 4.78mg/l. Median MRP was calculated as 0.04 mg P/l. Dangerous substances concentrations were below detection level for 5 of the 19 parameters tested in April 2009. No levels exceeded the standards as outlined in the Water Quality (Dangerous Substances) Regulations 2001.

Results from the downstream monitoring site (aSW1(P)d) indicates generally good water quality with average orthophosphate levels of 0.40 mg/l P recorded for 2007 and 2009, average ammonia 0.04 mg/l NH₃-N, average BOD of 2.2 mg/ls average TP of 0.14 mg/l, average TN of 1.65mg/l N and average suspended solids of 4.78mg/ls Median MRP was calculated as 0.04 mg P/l. Dangerous substances concentrations were below detection level for 6 of the 19 parameters tested in April 2009. No levels exceeded the standards as outlined in the Water Quality (Dangerous Substances) Regulations 2001

The assimilative capacity calculations indicate that there is significant dilution capacity within the receiving water, even at low flows, to assimilate discharges from the Waste Water Works in terms of suspended solids, BOD and Total Phosphorous and that the EQS are met downstream of the discharge point for the mean, 50-percentile and 95-percentile flow conditions.

The results of the assimilative capacity are consistent with the physiochemical water quality monitoring results (Monaghan County Council Data) and indicate that the discharges from the works are not having a significant detrimental impact on the receiving environment.

From **Table 1** below 36 hectares of land is available for residential development (70% of lands available).

At low density (15 houses per hectare) it is anticipated that approximately 540 housing units could be built during the Development Plan period if all land within the development limit was used for residential development. This could be a maximum population increase of 1674 based on an average household occupancy of 3.1. This would give a PE of 2244 (worst case scenario) which would leave the treatment plant over capacity. However, granting of developments would have to reflect the capacity of the WWTW.

Table 2 below tabulates planning permission granted/Conditional (from 2008 to present) and associated population equivalents resulting from these permissions. This table was compiled in using Monaghan County Council's ePlan. The existing loading of the plant is approximately 550 PE. The total committed but not yet contributing is 201.5PE (based on planning permissions granted or conditional from 2008 to present (**Table 2**)). The design capacity of the plant is 1000 PE, therefore the available capacity is 248.5 PE.

As the plant is currently designed to cater for a PE of 550, it will be able to accommodate the extra hydraulic and organic load without posing an environmental risk to the receiving water habitat.

There are no storm water overflows on the network.

There is one emergency overflow located at the WWTP at 264465E 318874N. This overflow discharges to the unnamed River downstream of the discharge point (see **Drawing 6**).

There are two CSO on the network located at 264356E, 318991N and 264603E 319246N.

C.1.2 Pumping Stations

There is one Pumping Station called Crann Mor on the Rockcorry network at NGR 264342E 318895N (**Drawing 2**).

The Crann Mor pumping station houses two pumps which operate in a duty-standby arrangement.

Design data for the pumping station is outlined below:

Peak Inflow Flow: 0.79l/sPumped Flow Rate: 2.5l/s

Rising main diameter: 50mm bore MDPE

• Rising Main Length: 300 metres

When there is a power cut the pumps reset automatically.

The caretakers check the plants 7 days a week so would check the Pumping Station on the Saturday or Sunday in the event of a power failure to make sure pumps reset.

Details of storage capacity at each pump station;

There is a 25m³ overflow tank which has 2.9 days storage capacity

 Frequency and duration of activation of emergency overflow to receiving waters. Clarify the location where such discharges enter the receiving waters.

There has never been an emergency overflow incident from this Pumping Station.

C.1 (i) Rockcorry Waste Water Works

The Waste Water Treatment Plant (WWTP) which provides treatment for a design load of 1000 population equivalent comprises aeration by mechanical surface aerators followed by settlement and clarification and treatment to reduce phosphate levels. The plant is designed to produce a fully nitrified effluent of 10:10mg/LBOD: Suspended Solids. Sludge from the Rockcorry Waste Water Treatment plant is tankered to Monaghan Town WWTP for treatment. The site plan and schematic arrangement of the Waste Water Treatment Plant is shown on **Drawing 2** of **Attachment 52** and **Drawing 6** of **Attachment C1**.

The plant is supervised/manned 7 days a weeks for a minimum of 2 hours, giving a minimum total of 14 hours a week.

1.2 Treatment

The treatment works consists of the following treatment units:

- Inlet Works
- Septic Tank
- Inter Stage Pumping Station
- High Rate Bio Filter
- Clarifiers
- Storm Water Holding Tank

Raw Effluent Screen

The sewage enters the treatment works via an inlet sewer manhole. From here it pass through a Haigh ACE 290 inlet screen.



Overflow liquid is discharge by gravity to the storm water holding tank

Septic Tank

There is one septic tank.

The following drains into the septic tank:

- Return sludge from the sludge sump at the clarifiers

 Stormwater from the stormwater bolding.

The storm water and return sludge join into common line before discharging into the septic tank. Two reflux values are provided on this common pumping main to prevent back flows into the clarifiers or stormwater holding tanks when pumping from either.

Interstage Pumps, Sump and Valve Chamber

An interstage pumping station is constructed of reinforced concrete and located immediately downstream of the septic tanks the settled effluent from the septic tanks is pumped to the bio-filter.

The sump contains the following components:

- 2 No. Submersible ABS pumps and 10 point multitrode (sensor)
- 2 No. Emergency stops and isolator switches

The following liquid drawing into the sump:

- Balanced effluent from the septic tank
- Recycled effluent flows by gravity from the clarifier outlet
- Surface water from adjacent valve chamber

A high level overflow pipe is also provided within the sump. This discharges to a 300mm diameter stormwater overflow pipe leading to the stormwater holding tank form the inlet chamber.

The valve chamber positioned beside the interstage sump contains the isolation valves and non return valves for the discharge side of the interstage forward feed pumps.

The pumping station forward feed pump set comprises 1 no. Duty and 1 no standby ABS pumps. Each pump is wired via an isolator complete with an emergency stop. Each pump is designed to deliver 7.8l/s.

High Rate Bio Tower

The high rate Bio Tower is constructed in reinforced concrete above ground level and measures 7m in diameter internally x 1.8m Av. Media depth.

The bio tower is designed to treat an organic loading of 0.38 kg BOD/d per m^3 of plastic media. The bio tower contained 70m^3 of random plastic media. Each m^3 of media provides up to 100m^2 of surface area.

The effluent is pumped from the interstage forward feed pumps to an elevated chamber which distributes flows to the rotary distributor which is mounted centrally on a concrete pedestal. The media is supported on a sloped under drain system covering the base of the tank which transports the effluent to the outlet point. The under drains also provide a natural current of air to diffuse upwards through the filter providing oxygen to the microorganisms.

The Phosphorous Removal Dosing Plant

The Phosphorous Removal Plant consists of the following components:

- 5m³ storage tank
- Metering pumps (duty/standby)

The ferric sulphate storage tank is constructed of polypropylene and has a capacity of 5m³. The tank has the following components:

- A drain port
- A delivery port
- Fill line
- Overflow pipe
- A vent
- Level indicator
- A 600mm manway

Ferric sulphate is delivered in liquid form (8%) and is dosed neat from the tank without dilution or mixing.

Two pumps (duty/Standby) are used to dose the Ferric Sulphate. Each pump has a capacity to dose 0-12l/h, each having an internal/off/external switch, stroke and pulse control and isolation value and pressure control valve on the delivery side. The Ferric Sulphate is dosed into the treated Bio Tower effluent discharge line.

<u>Clarifiers</u>

Each of the 2 no, hopper bottomed clarifiers are designed to treat up to a maximum of 14m3/h with an upward flow velocity of 0.875m/h. Each of the tow units measure $4m \times 4m$ internally with a 1m sidewall and 60° sloping sides toward the central hopper. The clarifier consists of the following components:

- Inlet flow splitter chamber c/w sludge pump
- Wedge wire panelling
- Scum box with drain valve
- Sludge bleed valves
- Sludge sump with forward feed pumps and valve chamber

Treated effluent from the Bio Tower flows by gravity through a splitter chamber which divides the flow equally between each clarifier. The settleable particles fall to the hopper bottom of each clarifier while the supernatant overflows the outlet weir for final discharge/recycling to the interstage sump.

The recycle to the interstage pump sump is achieved by opening the hand stop in the clarifier outlet chamber upstream of the baffle in the chamber. In normal operation this hand stop is "open". The baffle in this chamber ensures that the gravity pipeline between this chamber and the inter stage is primed.

Discharge to the interstage sump is controlled by an equilibrium float valve. When the liquid level in the interstage pump sump is low the float valve opens and allows recirculation from the clarifier outlet chamber to take place. Then as the level in the interstage pump sump increases the float valve closes and recirculation ceases. This arrangement ensures that even at times of low inflow to the works the interstage pumps maintain the required wetting rate to the biological filter.

When the inflow is low, recirculation is taking place and the recorded outlet flow is equivalent to the inflow rate. At times of storm flow no recirculation takes place and the recorded outlet flow is equivalent to design flow through the plant i.e. 7.5l/s.

A manually operated scum box is positioned 50mm below the top water level in each clarifier to remove scum that may accumulate on the surface over time. The effluent from the scum box flows by gravity to the sludge sump.

Wedge wire covers the full area of each clarifier and is positioned 430mm below the water level. The wedge wire helps to maintain a strong studge blanket and ensure minimum solids overflow in the supernatant.

The Sludge Pumps, Sump and Valve Chamber

An R.C pumping station is attached to the clarifiers, the sump of which contains the following components:

- 2 submersible ABS pumps and 10 point multitrode
- 2 emergency stops and isolator switches

The following liquids drain into the sump:

- Sludge from clarifiers
- Clarifier scum via the scum boxes
- Surface water from the valve chamber sump.

The valve chamber on the sludge pumping station contains the isolation valves and non return valves for the discharge side of the sludge feed pumps.

The pumping station sludge feed pump set comprises of 1 duty and 1 standby ABS pump. Each pump is wired via an isolator complete with an emergency.

Stormwater Holding Tank & Return Pumps

The stormwater tank is constructed of concrete below ground level. The base of the tank is hopper shaped. The stormwater storage tank contains the following:

- 2 submersible ABS pumps and 10 point multitrode
- 2 emergency stops and isolator switches

The following drains into the sump:

- Storm water from the overflow of the inlet screen when flow > 6DWF
- Runoff from the valve chamber sump

In high flood situations and when the flow measured in the outlet V notch weir is >3.9l/s, the stormwater storage tank will overflow to the river via a high level overflow weir within the tank.

The stormwater return pump set comprises 1 no duty and 1 no. Standby ABS pump. Each pump is wired via an isolator complete with an emergency stop. Each pump is designed to deliver 2.6l/s (2 DWF). The pumps operate to a 1 point multitrode within the sump. The sensor is pre-set for low level cut out of the pumps.

Flow Measurement

Flow measurement of treated final effluent prior to being discharge to the River is performed by a Danfoss EMUC 1054 ultrasonic flow meter and a V notch weir. The V notch weir and baffle plate is located in a sump constructed of concrete.

A baffle is located 200mm from the inlet pipe in the weir to prevent turbulence on the surface of the effluent which would cause erroneous and fluctuating flow measurements.

There is one emergency overflow located at the WWTP at 264465E 318874N. This overflow discharges to the unnamed River downstream of the discharge point (see **Drawing 3**).



The Monaghan County Council laboratory carries out the sampling of the discharges from the Rockcorry Waste Water Treatment Plant and the monitoring of the water in the Dromore River System upstream and downstream of the primary discharge. Sampling of the primary discharge from the Rockcorry Waste Water Treatment Works and the monitoring of the upstream and downstream monitoring locations are undertaken every 6 weeks. At present composite samples are taken of the influent and effluent and grab samples are taken for upstream and downstream monitoring points.

Monaghan County Council Laboratory and Euro Environmental is on the register of approved laboratories submitting data to the EPA. This register has been compiled in compliance with Section 66 of the EPA Act 1992.

Section 66 of the Environmental Protection Agency Act 1992 provides for the establishment of an intercalibration programme for the purpose of assessing analytical performance and ensuring the validity and comparability of environmental data for laboratories which submit data to the Agency. It also provides for the establishment of a register of quality approved laboratories.

Monitoring, Sampling & Analytical Procedures

Careful collection is carried out during all sampling to ensure that the relative proportions or concentrations of all pertinent components are the same in the samples as in the materials being sampled. The samples are also handled carefully to ensure that no significant change in the composition occurs before the tests are made.

During the waste water and water sampling all personnel wear safety boots and latex gloves at all times. Due care and attention is taken at all times.

All of the sampling points are located in places that have safe means of access.

The variability of the discharges and their effects on the receiving environment has been considered in determining the sampling programme. Equipment calibration and equipment maintenance are carried out in order to ensure accurate and reliable monitoring.

General

The outfall from the Rockcorry Waste Water Plant discharges to the an unnamed river in the Dromore River System at National Grid Reference 264465E, 318871N in the Townland of Boyher, Rockcorry Co. Monaghan Co. Monaghan.

The river flows into Drumlona Lough and onto the Dromore River which is a tributary of the Erne System (see EPA Map below). The promore River is not designated sensitive under the UWWTR and the provision of nutrient reduction is not a legislative requirement under these regulations. The water body is at risk of failing to meet good status in 2015. The Drumlona Lough overall water quality status is strongly eutrophic with maximum chlorophyll of 58 (EPA, 2004). This eutrophic status is caused by enrichment of the water by nutrients (especially phosphorous and/or nitrogen compounds) causing accelerated growth in algae and other plant forms which causes an undesirable disturbance to the balance of organisms present in the water and the resultant quality of the water.

The treated effluent has an average BOD concentration of 11.5mg/l and average suspended solids concentration of 16 mg/l. Average concentrations of nutrients are as follows; orthophosphate 5.79 mg/l (P), Total Phosphorus 1.93 mg/l (P) and Total Nitrogen 18.4 mg/l (N).

There is no hydrometric station or EPA monitoring station on the river or in the vicinity of the river to which the effluent discharges. The nearest flow monitoring station where data is available for the Dromore River is at Ashfield in County Cavan. The flow in the Dromore River at Rockcorry was estimated based on the estimated catchment area and using the flows from the Ashfield Station.

Monaghan Co. Co. monitors the river both upstream and downstream of the discharge from the Waste Water Works. These locations are shown on **Drawing 4** of **Attachment B3**. Monitoring data collected for the year 2008 and 2009 is presented in **Tables F.1(i)a aSW1(P)u** and **aSW1(P)d**. Monitoring results for dangerous substances relate to a once-off samples collected in February 2009 and are presented in **Tables F.1(i)b aSW(P)u** and **aSW(P)d**.

Monaghan County Councils upstream monitoring results indicate relatively good water quality in the river, with the average orthophosphate level recorded at 0.39 mg/l P, average ammonia levels of 0.03 mg/l NH₃-N, average BOD of 2.1 mg/l, average TP of 0.14mg/l, average TN of 1.69mg/l N and average suspended solids of 4.78mg/l. Median MRP was calculated as 0.04 mg P/l. Dangerous substances concentrations were below detection level for 5 of the 19 parameters tested in April 2009. No levels exceeded the standards as outlined in the Water Quality (Dangerous Substances) Regulations 2001.

Results from the downstream monitoring site (aSW1(P)d) indicates generally good water quality with average orthophosphate levels of 0.40 mg/l P recorded for 2007 and 2009, average ammonia 0.04 mg/l NH₃-N, average BOD of 2.2 mg/l, average TP of 0.14 mg/l, average TN of 1.65mg/l N and average suspended solids of 4.78mg/l. Median MRP was calculated as 0.04 mg P/l. Dangerous substances concentrations were below detection level for 6 of the 19 parameters tested in April 2009. No levels exceeded the standards as outlined in the Water Quality (Dangerous Substances) Regulations 2001.

The impact of the primary discharge point on the River is evaluated in the Assimilative Capacity calculations below.

Assimilative Capacity of Receiving Water

The Assimilative Capacity of the receiving waters is a measure of its ability or suitability to absorb waste water discharges whilst complying with relevant legislation and water quality objectives.

The impact of the primary discharge point on the River is evaluated in the Assimilative Capacity calculations below.

As noted above there is no hydrometric station on the river or in the vicinity of the river to which the effluent discharges. The nearest flow monitoring station where data is available for the Dromore River is at Ashfield in County Cavan. The flow in the Dromore River at Rockcorry was estimated based on the estimated catchment area and using the flows from the Ashfield Station.

The OPW has an average flow measurement and catchment area at Ashfield as follows:

There are no low flow readings. It is estimated that the average flow is 15 times the 95 percentile flow based on similar catchments in the area. The 95-percentile flow is estimated as follows:

The flow in the Dromore River at Rockcorry is estimated based on the estimated catchment area as follows:

- 95 percentile flow per m²: 0.0012 m³/m²/sec
- Mean flow per m²: 0.01726 m³/m²/sec

- Mean flow (m³/s): 0.705 m³/s

Using the River flow rates outlined above and the River's background water quality (Monaghan County Council Data), an assimilative capacity assessment of the River has been carried out using the average flow and 95-percentile flow conditions for BOD, SS and Total Phosphorous and MRP.

The assessment has been undertaken on the basis of an average discharge flow to the receiving water from the Wastewater Treatment Plant.

The above calculations indicate the discharge, in terms of BOD concentration, is not impacting on the water quality of the river and the resultant concentration downstream is within the EQS of <4mg/l for all flow conditions.

Phosphorous Assimilative Capacity

Based on the Q value and MRP targets for the Dromore River, we are presuming a Q value of 3-4 or Molybdate-Reactive Phosphate Median Concentration(ugP/L) of 50 (Phosphorus Regulations, 1998) is to be achieved to this water body.

The calculations above show that the River to which the effluent discharged has the capacity to assimilative the discharge in terms of Suspended Solids and indicate that the suspended solids EQS (25mg/l) is met downstream of the discharge point.

Summary

The assimilative capacity calculations above indicate that there is significant dilution capacity within the receiving water, even at low flows, to assimilate discharges from the Waste Water Works in terms of suspended solids, BOD and Total Phosphorous and that the EQS are met downstream of the discharge point for the mean, 50-percentile and 95-percentile flow conditions .

The results of the assimilative capacity are consistent with the physiochemical water quality monitoring results (Monaghan County Countil Data) and indicate that the discharges from the works are not having a significant detrimental impact on the receiving environment.

Phosphorus Removal

The treatment works includes a facility for the removal of phosphorus. The phosphorus is removed by simultaneous precipitation by the addition of ferric sulphate which acts as a coagulant.

There is an average 74.7 % reduction of P concentration between the inlet and outlet to the plant. The maximum % reduction achieved in 2007-09 was 81.5% and the minimum achieved was 39%.

Physicochemical results from samples taken at the Monaghan County Council's monitoring sites upstream (aSW1(P)u) and downstream (aSW1(P)d) of the discharge point indicate an median MRP concentration of 40ug/I P upstream and 50ug/I P downstream of the discharge point (based on TP concentrations).

The above results shows that there is no major influence of the discharge on the TP and MRP concentrations in the River, with no significant increase in the TP or MRP concentrations upstream and downstream of the discharge location.
