In response to your email, by the **total quantity of waste to be placed at the landfill (over authorised life of the facility)**, we mean the **total space between the formation levels of a landfill to the final profile expressed in cubic metres.**

In other words, it is the total space that has been filled with waste from the start of an authorised by a waste licence landfill operation until now **plus** the space that remains to be filled with waste to the end of the landfill operation.
