Dear Ewa,

In reply to the above notice, we wish to make the following submission in accordance with Article 9 of the Council Directive 1999/31/EC of 26th April 1999 (on the landfill of waste).

As per Table 3.4.2 of Volume II of the EIS submitted in support of the application for a review of waste licence W0201-01, and Schedule A.2.2 of waste licence W0201-02 (as amended), the total quantity of waste to be placed at the Drehid landfill (over the authorised life of the facility) is 5,040,000 cubic metres.

This amount is calculated by reference to:

the total tonnage of 4,080,000 tonnes
at 0.85 tonnes per cubic metre
and a landfill cover requirement of 5% of waste volume

as follows:

$$4,080,000 \times ((1+0.05)/0.85) = 5,040,000$$
