Caroline,

I gave EWA three different scenarios in relation to capacity.

1. Total Licence capacity extension area is 2,000,000 m³. Therefore, 1999 to projected closure would be 2,990,181.
2. Total capacity extension area with planning is 800,000 m³. Therefore, 1999 to projected closure would be 1,790,181.
3. Total developed available capacity extension area is 398,000 m³. Therefore, 1999 to projected closure would be 1,388,181.

Further to your query yesterday afternoon and my recent submission to Ewa Babiarczyk, the following is the additional information requested.

Limerick County Council were first granted a waste licence (17-1) for Gortadroma Landfill on the 26th November 1999. The total amount of waste landfilled in Cells 7 to 13 (November 1999 to October 2007) was 693,127 tonnes. During this period Limerick County Council operated a smaller compacter (30 tonne) and only achieved a Compaction rate of 0.7 tonne per m3. Therefore, 990,181 m3 of landfill space was filled in this period.
