Further to our telephone conversation of yesterday, I attach the following figures as requested. Please note a number of assumptions have been made in compiling these, namely:

- The quantity of waste deposited in the unlined cell following the granting of a waste licence is an estimate only.
- I have used a bulk density of 0.81 tonnes/ cu. m. for waste which includes 5% for cover.

Date landfill opened: Oct 1076
Date licence granted: Nov 1999
Approx. capacity of unlined cell

450,000 T

Quantity deposited after licence granted in unlined cell:	300,000 Tonnes
Quantity of waste deposited in existing lined cells to-date:	180,000 Tonnes
Remaining capacity of existing lined cells:	130,000 Tonnes
Remaining capacity of undeveloped cells :	954,000 Tonnes

Total quantity of waste already deposited and remaining capacity in Derryclure Landfill since a waste licence was granted: 1,564,000Tonnes (1,266,840 cu. m.).
