We do not have an exact record of when the cells were filled but based on an examination of the AER files available I would estimate the following:

The original licence was issued in March 2000 and since that time a total of 179,000 tonnes were landfilled in cells 9-13. To date a total of 105,000 tonnes have been filled in cells 15-16 out of a total of 240,000.

Therefore a total of 419,000 tonnes will be filled from the time of authorisation (March 2000) to the closure of the landfill.
