Dear Ewa Babiaczyk,

The Agency requested the following information relating to Article 9 of the Council Directive 1999/31/EC of 26 April 1999 (on the landfill of waste).

"1. Provide one figure in cubic metres for the quantity of waste to be placed at the landfill (over authorized life of the facility). Provide information on the way this information has been calculated."

The facility during the authorized life of the facility under Waste Licence W0009-02 will have 1.29 million m3 of waste or 1.04 million tones of waste placed therein. This was calculated on the basis of the void space measured in the design proposals for the newly engineered cells in the application for Waste Licence W0009-02. Please see below Introduction from WL W009-02 which discusses this matter.
