Dear Marie,

I refer to the above application and in particular to our response to the 'quality protocol' which was emailed to you on September 10th. I would further refer you to the acceptable levels of ash in the proposed recycled oil product. Initial ash levels of 0.15%, as proposed in the original application, were based on the 'interim standard' published by the Environment Agency in the UK. Subsequently the EA have published the 'quality protocol' which will supersede the interim standard. In the quality protocol an ash level of 0.20% is detailed. Rilta Environmental would request that, as the quality protocol details the most up to date and approved reprocessed oil quality criteria, a level of 0.20% be applied in the above proposed licence. While our investigations and testing are ongoing, we would feel that this level is attainable on an ongoing basis. We are also confident that this, along with the other suggested parameters would constitute a significantly cleaner 'reprocessed oil product' than anything currently being produced in the UK and Ireland.

I accept this a late submission and appreciate your acknowledgement of my recent phone call, but we are trying to set a standard that is both attainable and does not present a hazard to the environment. I also trust that this late submission will not cause a delay to the proposed decision to W0192-03.
