## WASTE MANAGEMENT ACTS, 1996 to 2008

## TRANSFER OF A WASTE LICENCE

Decision of the Agency, under Section 47(5) of the Waste Management Acts, 1996 to 2008

Waste Licence Register No: W0144-01

The Agency, in exercise of the powers conferred on it by the Waste Management Acts, 1996 to 2008, for the reasons hereinafter set out, hereby transfers waste licence register number W0144-01 from Sean Rooney Limited trading as Bambi Bins & Wheel Bin Services Limited, Coes Road, Dundalk, County Louth to Oxigen Environmental Limited, Coes Road, Dundalk, County Louth, Waste Licence Register No W0144-01 licenses the carrying on of the waste activities set out below at Coes Road, Dundalk, County Louth subject to twelve Conditions, as set out in the waste licence.

Licensed Waste Disposal Activities in accordance with the Third Schedule to the Waste
Management Acts, 1996 to 2008

Class 13. Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced.

This activity is limited to storage at the facility prior to bulking and transfer of waste.

Licensed Waste Disposal Activities in accordance with the Fourth Schedule to the Waste Management Acts, 1996 to 2008

Class 2.	Recycling or reclamation of organic substances which are not used as solvents (including composting and other biological transformation processes):
	This activity is limited to the separation of biodegradable waste at the facility using a trommel prior to transport elsewhere for composting.
Class 3.	Recycling or reclamation of metals and metal compounds:
	This activity is limited to the recovery of steel and metals at the facility.
Class 4.	Recycling or reclamation of other inorganic materials:
,	This activity is limited to the recovery of construction and demolition wastes at the facility.





Class 13.	Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced:
	This activity is limited to the storage of waste at the facility prior to recovery.

In accordance with Section 47(6) of the Acts, Oxigen Environmental Limited is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, they may arise.

## REASONS FOR THE DECISION

Pursuant to Section 47(5)(a) of the Acts, the Agency is satisfied, on the basis of the information available, that Oxigen Environmental Limited is entitled to be regarded as a fit and proper person to be granted a like waste licence. Pursuant to Section 47(5)(b) of the Acts, the Agency is satisfied, on the basis of the information available, that Oxigen Environmental Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the report of its inspector.
