Please use the register number of the waste licence, W0024-04, in any future communication in respect of same and include an original and two copies of all items in the correspondence.


You will be contacted in due course by an inspector in the Office of Environmental Enforcement, Environmental Protection Agency, who will discuss the implementation of the conditions of the licence.


I refer to the objection to the Agency's proposed decision on the above referenced review of a waste licence.


