## TECHNICAL AMENDMENT C TO WASTE LICENCE

### Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. W0015-01 granted on 25/08/2000, and amended on 09/08/2005 and 16/01/2006, as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Acts 1996 to 2010.

#### Technical Amendment

In pursuance of the powers conferred on it by Section 42B(1)(c) of the Waste Management Acts 1996 to 2010, the Agency amends Licence Reg. No. W0015-01, granted to Dun Laoghaire-Rathdown County Council, Town Hall, Marine Road, Dublin Laoghaire, County Dublin.

Henceforth, the Licence shall be read in conjunction with the amendment set out below, which shall be cited as Amendment C.

This technical amendment is limited to the following conditions:

#### Amendments

Delete condition 1.2 of the existing licence and replace with the condition below.

1.2 For the purposes of this licence, the facility authorised by this licence is the area of land outlined in red on Drawing No. DG218/Rev. A01 'Revised Licence Boundary' dated July 2009. Any reference in this licence to "facility" shall mean the area thus outlined in red. The licensed activities shall be carried on only within the area outlined.

Insert new condition 9.16 as follows:

- 9.16 The licensee shall reinstate the following monitoring infrastructure:
  - (i) Landfill gas monitoring wells GW10a, GW11, GW12a and GW75a;
  - (ii) Groundwater monitoring wells MW2D, MW2S, MW13D and MW13S; and
  - (iii) Dust monitoring point D2A

in the revised locations identified on Drawing No. 3788-01/Rev. C1 by 31<sup>st</sup> December 2010, unless otherwise agreed by the Agency.

This technical amendment shall be cited as Amendment C (in pursuance of Section 42B(1) of the Waste Management Acts 1996 to 2010) to Waste Licence Register No.W0015-01.
