7 Insert new condition to read: *Prior to the acceptance of waste for deposition at the facility, the licensee shall establish and operate a programme to measure resources and energy use. This programme shall also identify actions or measures that will be implemented to maximise efficiency of use of resources and energy at this facility. A copy of this programme shall be available on-site for inspection by authorised persons of the Agency and a summary report of consumption figures as well as efficiency measures/actions/innovations shall be submitted as part of the Annual Environmental Report.*

8.5 Amend this condition to define the area that can be used for storage of waste and limit the tonnage that can be stored prior to deposition/processing.

- 11.4 Amend to include a requirement for a summary of incidents to be included in the AER and amend Schedule F accordingly.
Insert new condition detailing a requirement for an annual gas assessment survey to be carried out;
Insert new enabling condition that requires the licensee to reassess their obligations under the Mine/Extractive Waste Regulations
Insert new condition which requires that the agreement of the Agency must be sought prior to the commencement of a new stage of deposition/infilling operations.

Following discussion, the Directors decided to grant a licence, as modified, to O'Regan's Quarry Products Limited, for their facility at Tulligmore, Dripsey, Co Cork, Register of Licence No W0255-01, subject to the conditions as set out in the licence.
