

Some local residents were quite understandably appalled, astonished by the deceit of one neighbour in particular who has sold as he clearly admitted last night, the site the proposed industry will be developed on. A lot of questions were fobbed off with him choosing which to answer and blithering honsense about heat. He avoided the questions he quite clearly did not have the answers to. I must admit, they did themselves no favours by muddling up information about water and hygiene, it was a total disgrace. Nobody should make promises that they are not in a position to keep. What if one of the lorries, God forbid, turns over and waste is emitted from the tank, who can say then that there isn't going to be a smell? Absolutely nobody, and that I'm sure of. Tony Dineen swore blind last night that 12 traffic movements would take place to and from the plant after they stated 8 in the Environmental Impact statementa bit of an inadequacy there isn't there, and if they got wrong how the hell are we supposed to believe a thing the say. How could anyone in their right frame of mind and with any consideration for children in particular allow such a development roughly about 100 vards from Tibohine National School to get the go ahead? Nobody

was there to represent the school at the meeting, but surely the need to take action before its too late. What kind of education are children going to receive with an industry operating across from the school all day, everyday? The windows and doors will have to be sealed everyday to block out fumes and noise. Playtime will be ruined for the children with the smells and the noises impacting severely on them. This SHOULD NOT UNDER ANY CIRCUMSTANCES BE ALLOWED TO HAPPEN. From articles I've read on the internet I understand that such a development has already been rejected in Waterford because Rapeseed production was going to pose respiratory problems to Horses! We can only begin to imagine the long-term implications this Biopark or waste treatment plant will have on our health. Actually I'm confused as to why it's being called a Biopark when in actual fact it will be dealing predominantly with waste?! Also L as the next generation of residents in the village, I have grave concerns that when this plant is up and running there is absolutely nothing to stop AD Power from selling this proposed plant 12months or whatever down the line and the plant being turned 100% into dealing with waste. There is no doubt but this is probably happen because there is no resources around here for renewable energy and the land can barley grow a good harvest of grass let alone rapeseed. I also have concerns about rapeseed because it appears it impacts severely on asthma and hay fever sufferers. If health problems in horses got that particular application rejected surely there is no way permission could be granted for a development with such close proximity to a school full of vulnerable children. The development of such a plant would be more suited to a boggy area where there is an absence of human and animal habitation, and **NOT** in the heart of a village surrounded by a large residential area, school, church and community centre which most certainly is not the place for it under any circumstances. It infuriates me to think that by this time next year the Tibohine I was born and raised in may be drastically different. I ask myself at this point how has planning gotten so far when the local community were kept so in

the dark? Surely that's a sign that they wanted to avoid opposition. Tibohine is a beautifully serene area with breathtaking views of the surrounding countryside in particular LoughGara Lake. What kind of view are we going to have with a factory operating 24/7 in our village? Not a very pleasant one I can imagine. The proposed factory will be just of the main N5 Dublin road connecting the village to the local town of Ballaghaderreen. Traffic is already heavy enough and any further contribution to traffic problems will be most unwelcome. On May 1st of this year the traffic jams into Ballaghaderreen due to a fair were enormous. The likes of it I have certainly never seen in a rural area and the town wasn't prepared to cope with the severity of the traffic. An increase in lorries into the area certainly will not be welcomed particularly at peak times. The factory will be located in close proximity to asvery dangerous bend which is prone to traffic accidents and has even seen a fatality. The lives of local residents should not under any circumstances be put in danger.
