**Recommended Decision on an Application for a Waste Licence**

*Licensee:*       **Irish Packaging Recycling Limited  
T/A Panda Waste Services  
Ballymount Road  
Walkinstown  
Dublin 12**

*Register of Licence No:* **W0263-01**

The Directors considered a recommendation from the Office of Climate, Licensing and Resource Use that the Agency approve the Recommended Decision to grant a Waste Licence. The following documentation was submitted: Recommended Decision; summary report of the Inspector; one Third Party submission and one First Party submission.

A copy of the licence application was available electronically.

**Inspector's Report**

The Directors noted the Inspector's Report.

It was noted that the OCLR will write to the County Manager detailing the EPA's legislative role regarding the EIA and making reference to correspondence received from the Environmental Services Section of South Dublin County Council and the Planning Department of South Dublin County Council.

**Recommended Decision**

The Directors did not approve the acceptance of Municipal Solid Waste at this facility. It was noted that the Directors recommended that the Recommended Decision is reviewed and that all references to; and any conditions specifically required for Municipal Solid Waste (MSW) are deleted.

**Introduction**

Amend final sentence in 3<sup>rd</sup> paragraph to read: The facility will be licensed to accept mixed dry recyclables *and construction and demolition waste, on a phased basis, totalling up to 150,000 tonnes per annum.*

**Condition**

- 3.10.1       Insert new sub-condition (v) to include a requirement for the integrity of the building to reduce noise potential.
- 3.11.1       Amend to read: *In advance of the date of commencement of acceptance of Construction & Demolition Waste at the facility, the licensee shall install and provide adequate measures for the control of*

- odour and dust emissions, including fugitive dust emissions, from the facility. *Such measures shall as a minimum include:*
- 3.11.1.2 Clarify the requirement for this condition.
  - 8.12 Clarify this condition and amend to include the standard wording for similar type facilities.

***Schedule***

***A.2 Waste Acceptance***

Delete the reference to *Mixed Municipal Solid Waste* (MSW) under the Waste Type column and reduce the Maximum Tonnes Per Annum to 150,000.

Following discussion, the Directors decided to grant a licence, as modified, to Irish Packaging Recycling Limited, T/A Panda Waste Services Limited, for their facility at Ballymount Rd, Walkinstown, Dublin 12, Register of Licence No W0263-01, subject to the conditions as set out in the licence.
