WASTE LICENCE

Decision of the Agency, under Section 46(8)(a) of the Waste Management Acts, 1996 to 2008

Waste Licence Register No: **W0021-02**

Further to notice dated the 19th day of October 2009, the Agency in exercise of the powers conferred on it by the Waste Management Acts, 1996 to 2008, for the reasons hereinafter set out in the attached Decision, grants this revised waste licence to Mayo County Council, Áras an Chontae, Castlebar, County Mayo, to carry on the waste activities set out below at Derrinumera Landfill Facility, Derrinumera/Drumilra (Townlands), Newport, County Mayo, Subject to eleven Conditions, as set out in the schedules attached thereto.

Licensed Waste Activities

*Waste Disposal Activities, in accordance with the Third Schedule
of the Waste Management Acts, 1996 to 2008:*

<i>Class 1:</i>	Deposit on, in or under land (including landfill).
<i>Class 5:</i>	Specially engineered landfill, including placement into lined discrete cells which are capped and isolated from one another and the environment.
<i>Class 6:</i>	Biological treatment not referred to elsewhere in this Schedule which results in final compounds or mixtures which are disposed of by means of any activity referred to in paragraphs 1. to 10. of this Schedule.
<i>Class 7:</i>	Physico-chemical treatment not referred to elsewhere in this Schedule (including evaporation, drying and calcination) which results in final compounds or mixtures which are disposed of by means of any activity referred to in paragraphs 1. to 10. of this Schedule.
<i>Class 13:</i>	Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced.

*Waste Recovery Activities, in accordance with the Fourth Schedule
of the Waste Management Acts, 1996 to 2008:*

<i>Class 2:</i>	Recycling or reclamation of organic substances which are not used as solvents (including composting and other biological transformation processes).
<i>Class 3:</i>	Recycling or reclamation of metals and metal compounds.
<i>Class 4:</i>	Recycling or reclamation of other inorganic materials.
<i>Class 13:</i>	Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced.
