In accordance with Article 34 of the Waste Management (Licensing) Regulations, the Agency hereby notifies you of its decision to grant a revised waste licence to Rilta Environmental Ltd (formerly known as SITA Environmental Ltd), subject to conditions, in respect of a facility at Rilta Environmental Limited, Block 402, Grant's Drive, Greenogue Business Park, Rathcoole, County Dublin.
