Country Clean Recycling Waste Licence Application Addendum (Waste Licence Ref: W0257-01)

Dear Sir/Madam,

Country Clean Recycling made an application to the Agency on the 5th of March 2009 for a Waste Licence Application for a Materials Recovery Facility at Churchfield Industrial Estate, John F. Connolly Road, Cork City.

Country Clean Recycling Ltd (CCR) has operated a Materials Recovery Facility at the site under a Local Authority permit since 2005. A plan to increase the waste throughput at the facility pushes CCR over the threshold of a Local Authority Licence and consequently CCR must hold a Waste Licence from the Agency for the activity at the facility.

Waste Licence Update

To permit the increased throughput of the facility, a Planning Application was made to Cork City Council requested permission to add additional infrastructure to process a larger quantity of waste at the facility. Planning Permission was granted for the facility on the 4th of March 2010.

During the Planning Application process, amendemnts were made to the planning application to satisfy the requirements of the Local Authority. An addendum to the Waste Licence application which reflects the Planning Permission granted by the Local Authority is appended with this letter.

An application for a Wastewater Discharge Licence was made to Cork City Council in May 2010 and CCR are currently awaiting a decision on this application. CCR expect to have a decision on the Discharge Licence by the end of the week ending the 23rd of July 2010, a copy of this Licence will be forwarded to the Agency upon receipt.

Food Waste

It is also noted that as a result of the Waste Management (Food) Regulations 2009, clients of CCR producing in excess of 50kg of food waste are regulations 2009, p: 066 7128321 f: 066 7180061 e: info@oes.ie w: www.oes.ie

this waste as a separate waste stream. To facilitate their clients, CCR plan to collect food waste from clients, transfer it to their transfer facility before sending it off site for composting at a licensed facilities.

CCR contacted the Licensing Officer (Ms Orla Harrington) processing the Waste Licence Application to ensure that this activity could be facilitated under the scheduled activity noted in the Waste Licence Application. The Licensing Officer noted that this activity could be accommodated under the Class of Activity in Application Ref W0257-01 and requested that a brief outline of the quantity, storage facilities and processing of the food waste be submitted to the Agency when sending through the Waste Licence Addendum.

As agreed, a description of the planned activity relating to food waste storage and collection is detailed in section H of the Waste Licence addendum.
