That being the case we would ask that requests for assessments for Boherbue, Bweeng, Conna, Glanworth and Clondulane be deferred until your requirements in relation to all licence/certificate applications for discharges to the Blackwater SAC, or to other SACs/SPAs in the catchment thereof, have been advised to us. This bundling of assessments to cover the entire Blackwater catchment area would minimise potential procurement costs and allow us to consider making budgetary provision for the cost in 2011.
