I am writing to you in relation to the above mentioned proposed development at Sarsfieldcourt Industrial Estate, Glanmire Co Cork. Please find enclosed cheque in the amount of €20 payable to the Cork County Council in payment of the planning submission fee.

I object to this proposed review of Waste Licence Reg. No. W0136-02 for the following reasons:

- 1. The health and safety of the residents and those working in the area is at risk of smells and gases which could be blowing from this development in all directions within the Industrial Estate. What effect would that have on the health and lifestyle of the residents and all those working in the area especially those working at my premises? We have had to suffer the obnoxious smells from this building for the past number of years and which was reported on many occasions to the Environmental Protection Agency at Inniscarra and also to the Manager of Greenstar, Sarsfield Court Ind Est. and although I have been promised that the smell would be reduced, it has in fact increased in recent times. I strongly object to any increase in waste acceptance or recycling that produces any smell in the area. What effect will this have on the Ozone layer? What effect will it have on the people working in this area or those using the sporting fields a short distance away or indeed the children living in the area?
- 2. In recent pasr the Environmental Protection Agency successfully prosecuted Greenstar Recycling (Munster) Ltd. for the continuing obnoxious smells in the Sarsfieldcourt Industrial Estate area.

- 3. The increase to 24 hour/7 days waste acceptance, process and operation would increase the traffic flow, noise and smells in the area and an increase in noise emissions is not acceptable. The roads leading to and from this development are narrow roads and such increase in traffic would be a danger to the community at large. Also the disturbance the traffic would cause would affect the residents and tenants alike in the area.
- 4. As this is an enclosed industrial estate the development of a Civic Amenity area would increases the waste acceptance and processing and the acceptance of hazardous household waste is not acceptable in this confined area. As a Civic Amenity area the traffic would increase enormously and traffic accidents could not be ruled out.
- 5. What safety precautions have been taken with this business if a major catastrophe happened?
