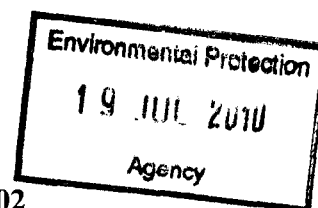

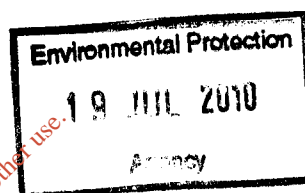

Dear Ms. O'Callaghan,

In regard to the telephone conversation we had on Wednesday 30th June 2010 about the status our waste licence review application the situation is as follows:

During our meeting on the 4th of March 2010 we outlined the situation in relation the planning refusal for our proposed development on our current site and that we had submitted a waste permit application for a building in Monahan Road in Cork City and that we were awaiting a decision to be made on our waste permit application. This was going to determine what way we wanted to proceed with the waste licence review.

The waste permit application for Monahan Road in Cork City has planning issues which have prevented a decision made on our waste permit application. This isn't something we had expected.

We have located another Building in Glanmire Co. Cork which has planning and had a waste permit previously.

We had a meeting with the Environment Section of Cork County Council in relation to the waste permit in Glanmire and they had no problems with what we were proposing to do on the site.

We are currently waiting on a meeting with the Cork County Council planning department to confirm that everything is in order and the appropriate planning is in place for the activities that we would be proposing to carry out.

Once we have met with the planners in Cork County Council planning department, I will write to you again informing you of the outcome of that meeting and what way we want to proceed with the waste licence review for our facility at Cullengh, Fermoy, Co. Cork
