I would like to bring to your attention that Country Clean Recycling Ltd have not received any update on its waste license application that was made to the EPA in February 2009 (Ref WO 257-01).

In the mean time our waste permit (WP02/07) from Cork City Council has expired. In May this year we made an application for an effluent discharge license and Cork City Council are now overdue in making a decision on this matter. While in July this year OES on behalf of Country Clean Recycling furnished the EPA with upper ated information on the current state of the site.

Country Clean Recycling also received planning permission (TP 09/33682) for on site construction works it plans to make as part of its waste license application.

Country Clean Recycling would like to request the possibility of receiving a temporary waste license to cover its current site activities. We fear that if the site is not covered by a waste license it may affect customer's confidence in our operation and may result in the loss of business.
