The Minister of State at the Department of Agriculture, Fisheries and Food, Sean Connick TD, has issued the following Fisheries Management Notices under section 12 of the Sea-Fisheries and Maritime Jurisdiction Act 2006:

Fisheries Management Notice No. 028 of 2010

This Notice sets restrictions on the catching, retaining on board or landing of Haddock in Area Vb, Via, Area Vlb, XII and XIV during October and November 2010. This notice should be read in conjunction with Fisheries Management Notice No. 27 of 2010 which sets similar restrictions for other demersal fisheries for a one month period (01 October 2010 to 31 October 2010) and also with Fisheries Management Notice No. 2010/033 which sets similar restrictions for Haddock in Area Vb, Via & Area Vlb, XII and XIV for a two month period (01 October 2010 to 30 November 2010).

Fisheries Management Notice No. 36 of 2010

This Notice sets restrictions on the catching, retaining on board or landing of various species of deep-sea fish during November 2010.

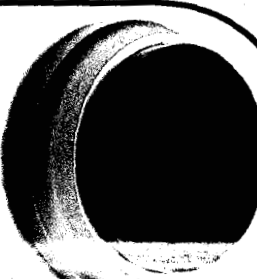
