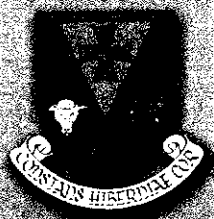


Further to my letter of 12th February regarding the Waste Licence Application reference W0274-01 by ABPower Roscommon Limited. I wish to add the following by way of clarification.

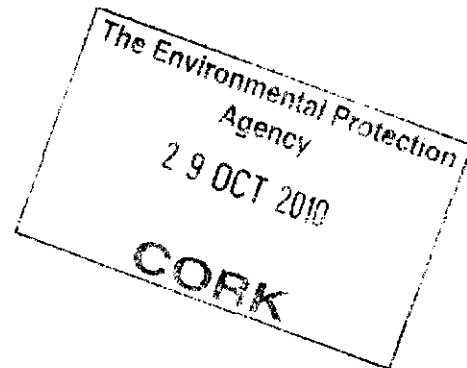
Planning Permission was granted for a Bio Park which includes, rape seed processing, bio diesel production, fuel pelleting and the construction of an anaerobic digester (20,000 t/a). The Bio Park will be an integrated development involving all of the elements referred to above.

It was proposed that the products from the Anaerobic Digester (heat/power) would be used to facilitate the Bio Fuel Production. In this context the use of agricultural waste, sludges etc is acceptable as part of the integrated development proposal. The Planning Authority expects that the integrated design permitted will be used and that the permission does not allow for stand alone elements of the process to operate independently.

It should be noted that the planning application referred to 20,000 tons of waste p/a while the EPA Licence Application is for 25,000 tons
