

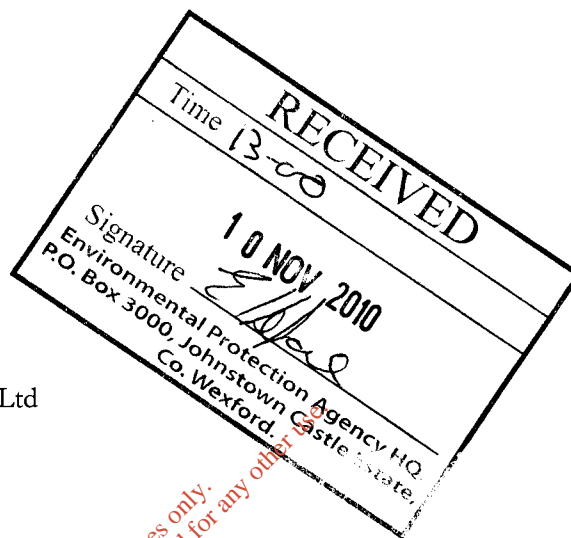

**Attachment H.1**

The area to which the licence applies is 3.5 Hectares (8.65 acres). The site is a spent gravel quarry which is no longer in use for gravel extraction. The North-Eastern section of the site has been back filled using inert natural soils in accordance with South Tipperary County Council waste permit Ref. Nos. WP/038-01. This area has been completely filled to its original ground level prior to quarrying period.

The proposed restoration works consists of the following items:

- Recovery of inert construction and demolition waste
- Importation, placement and compaction of inert soils and stones and recycled construction waste
- Returning site to original levels pre quarry period finished with a pastoral grass finish

The facility to be located at Garranmore, Cashel, Co.Tipperary is to apply the BAT so as to ensure the environmental issues are dealt with in a professional and correct manner. For the duration of the land filling process it will be crucial that only inert licensed materials is imported to the facility and used for backfilling and recovery.

Any non-hazardous or hazardous waste inadvertently mixed with the inert waste is to be segregated and brought to a waste quarantine area for additional examination. Any materials identified as non-hazardous or hazardous is to be removed off-site by a licensed body and disposed of at a licensed facility.

Based on the contour and site facility maps the life expectancy of the site can be calculated at 246m<sup>3</sup> per day. This amounts to approximately 68,000m<sup>3</sup> per annum. The total capacity of the site is 816,000m<sup>3</sup>. Therefore the life expectancy of the quarry is to be 12 years. Recovery of construction and demolition waste will only take place as long as the backfilling process is being undertaken.

- vi. Environmental monitoring of noise, dust, surface water and groundwater for the duration of the site restoration works.
- vii. Importation of 273,600 tonnes of inert waste as per note (i)
