

Dear Deidre,

Eco-Safe Systems (EPA waste license W0054-02) and SRCL Ireland (EPA waste license W0055-02) are waste management companies both operating in the Dublin area. Both companies are part of the Stericycle Group (<u>http://www.stericycle.com/</u>)

Due to the nature of operations at both facilities one of the major areas of concern is working within EPA license conditions.

Under license conditions it's a requirement for both facilities to carry out Culturable Enteroviruses analysis on effluent discharge to sewer. Between both facilities this would total 16 samples a year.

Up till recently this analysis was carried out in UK but now has ceased and I have not been able to find a facility that can carry out such analysis.

I have been in discussion with our EPA inspector and informed him of the situation. The EPA has requested that I contact the NVRL and seek clarification on whether the analysis can be carried out in Belfield.

If such analysis cannot be carried out without undertaking unreasonable action then the EPA have agreed to amend both facilities licenses to reflect such.

I would appreciate if you could take the time to replying as to whether the NVRL can carry out such analysis.


