The Directors considered a recommendation from the Office of Climate, Licensing and Resource Use that the Agency approve the Recommended Decision to grant a Waste Licence. The Directors noted that this was a review of Waste Licence No. W0012-02 applied for by the licensee, issued by the Agency on 2 February 2000.

Recommended Decision

Introduction

Insert new paragraph between existing paragraphs 2 and 3: The licensee will ensure that the activity is controlled to prevent environmental pollution, and to prevent nuisance beyond the site boundary of the facility. The waste Transfer Station building will be fitted with a negative air pressure system, with the emissions being treated in an odour/dust abatement system and waste will only be unloaded/loaded inside this building.

Glossary

Clarify wording of the definition for Groundwater.

6.16.3	Amend condition to read: The licensee shall identify under Schedule C.8.2 Groundwater monitoring, <i>in accordance with any guidance produced by the Agency</i> .
6.16.4	Clarify the appropriateness of the revision of trigger levels under the Landfill Directive and Groundwater Directive and associated Regulations.
	Amend condition to read: The licensee shall, within six months of date of grant of this licence, submit to the Agency for its agreement, a detailed programme of remediation measures to be undertaken for groundwater contaminants identified to the east and south-east of the landfill. The programme of measures shall have the objective of: (i) Limiting the input of pollutants into groundwater (ii) Preventing the deterioration of groundwater; and (iii) Enhancing the quality of the groundwater body in accordance with the requirements of the Groundwater Directive
6.16.5	Move this condition above existing condition 6.16.4 and re-number existing and subsequent Conditions accordingly.
6.16	Clarify appropriateness of amended Condition 6.16 with the requirements of the Water Framework Directive, Groundwater Directive and in particular the methodology completed by the Hydrometric and groundwater section in June 2010.

Following discussion, the Directors decided to grant a licence, as modified, to Cork County Council, for their facility at Kinsale Road Landfill, Ballyphehane, Curraghconway, Inchisarsfield, South Link Road, County Cork, Register of Licence No. W0012-03 subject to the conditions as set out in the licence.
