Anne,

Further to your phone call earlier regarding CBY.

As you note in section 1.3, on p11 of 37 of the NTS, 35I/s flows thru the system to be treated without restriction.

This equates up to 3 DWF.

The flow and load survey undertaken 12-18<sup>th</sup> Jan 2007 render an average PE=5692. (see P22 of 37).

If the average flow per person =175litres per person per day, then it follows 175\*5692=11.5L/s, which times 3 dwf=35L/s or 6dwf would be 70L/s.

I consider these figures conservative as Jan unlikely to have 5 days of DWF, so possibly 4dwf would go through under the 35L/s figure.

On page 12 of 37, it is noted flows between 35 and 70L/s go to storm O/f tank where they are stored until returned back via pumps at low flow period.

I trust this answers your question but if you have anything else please contact me.
