You are therefore requested, in accordance with Regulation 25(c)(ii) of the regulations, to take the steps to supply the information detailed below for **each** of the above named agglomerations.

## **REGULATION 24 COMPLIANCE REQUIREMENTS**

In the appropriate assessment screening received by the Agency on 31<sup>st</sup> January 2011, it was indicated that further assessment was required. Please complete same and submit to the Agency by 18<sup>th</sup> February 2011. You are advised to provide the requested information in accordance with the 'Note on Appropriate Assessments for the purposes of the Waste Water Discharge (Authorisation) Regulations, 2007 (S.I. 684 of 2007)' which is available at www.epa.ie/downloads/forms/lic/wwda/.

Your reply to this notice should include a revised non-technical summary which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one original plus one copy by 18<sup>th</sup> February 2011. In addition please submit one copy of the requested information in electronic searchable PDF format on a CD-ROM (no file to exceed 10MB) to the Agency. Please note that all maps/drawings should not exceed A3 in size.
