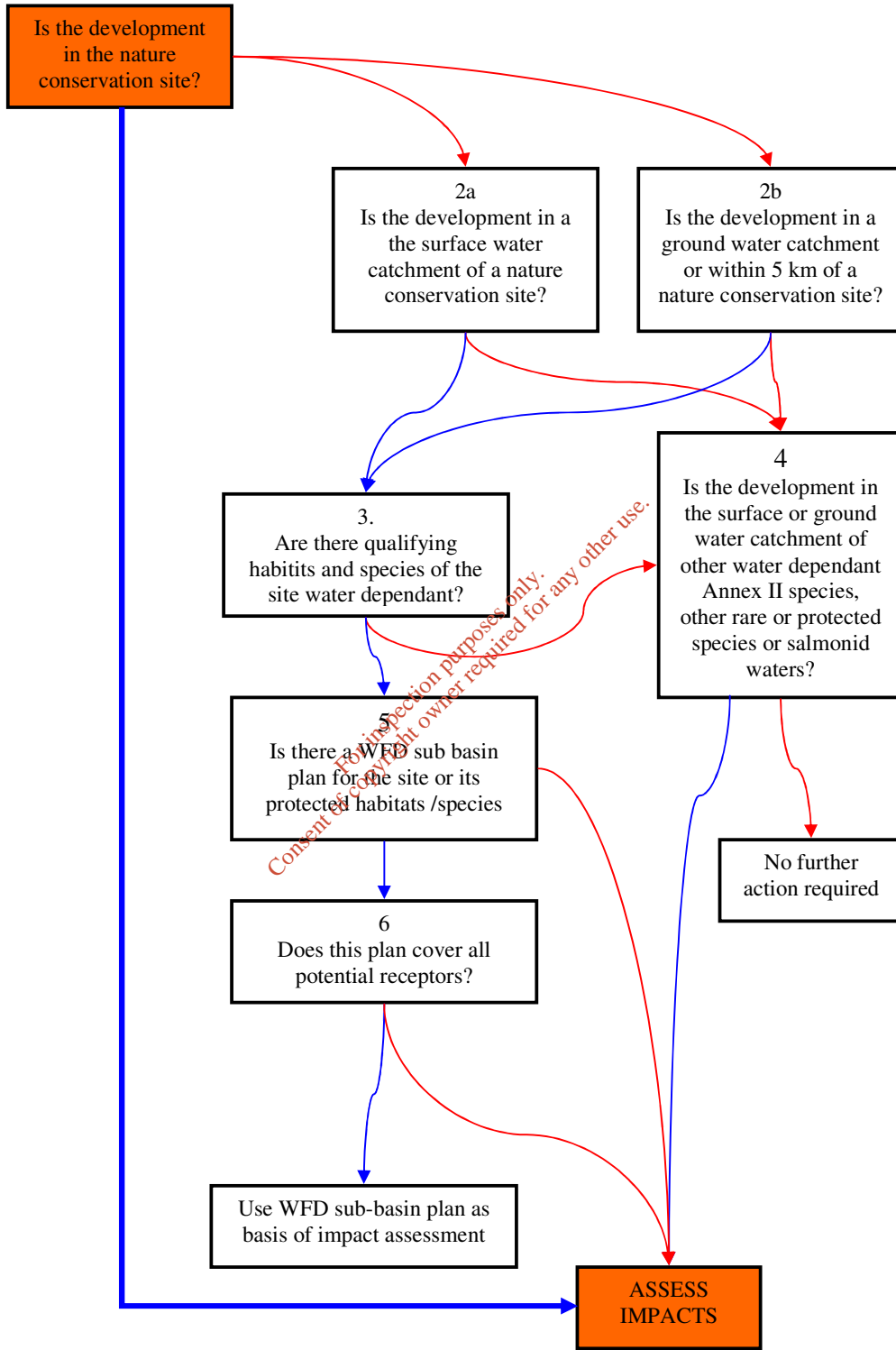

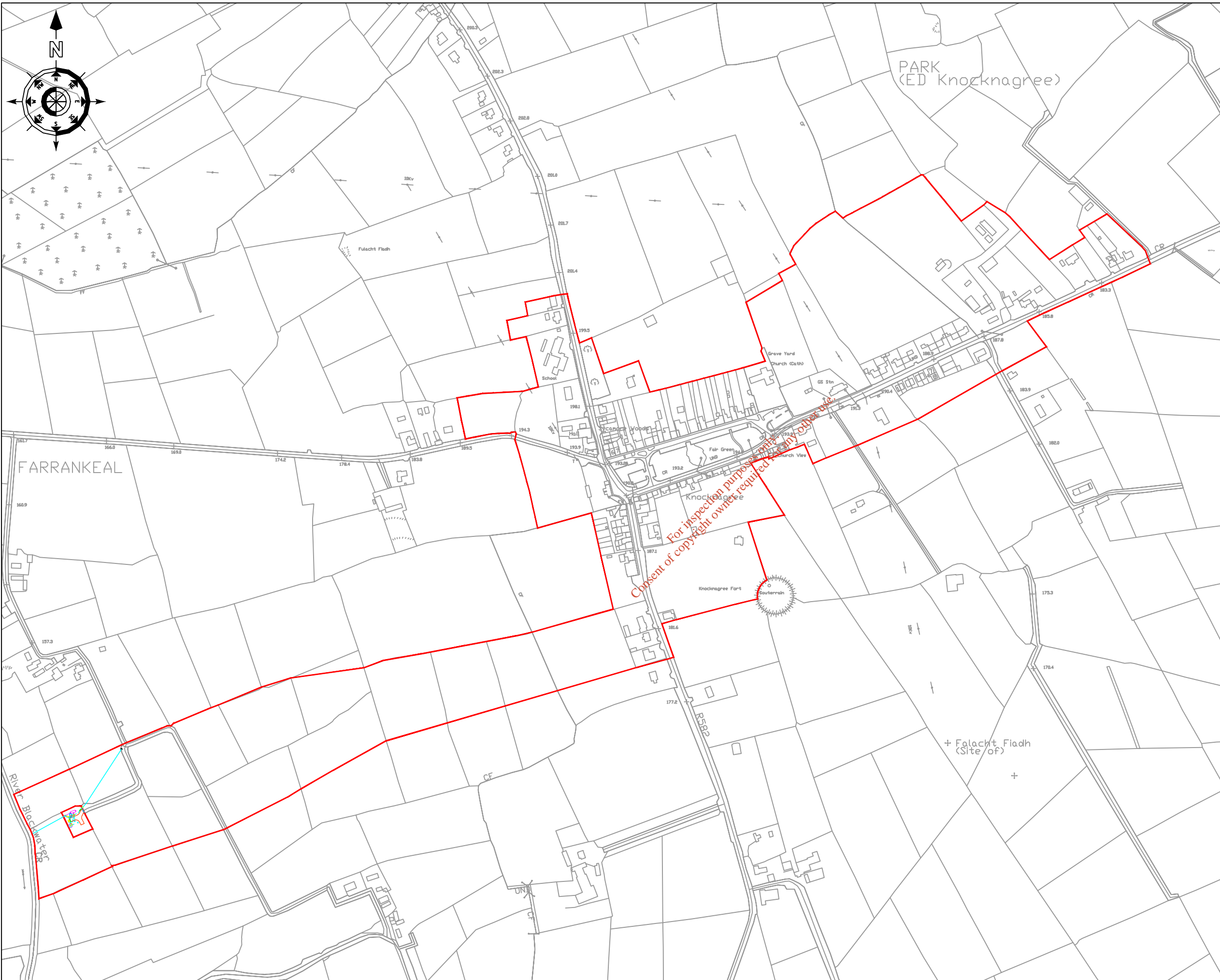
**Knocknagree Flow Chart – A0344-01
