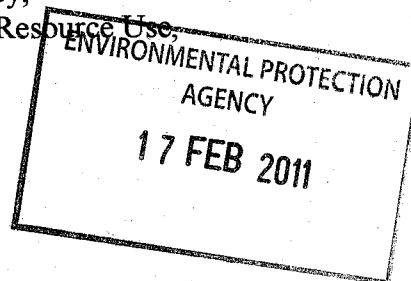

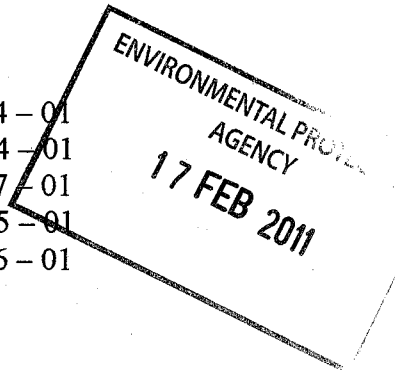

A consultant has been engaged to prepare an Appropriate Assessment of the effects of the discharges on the River Blackwater. I have requested the consultant to prioritise the Certificate Plants and he is hoping to complete the assessment relating to the Certificate Plants by the end of March.

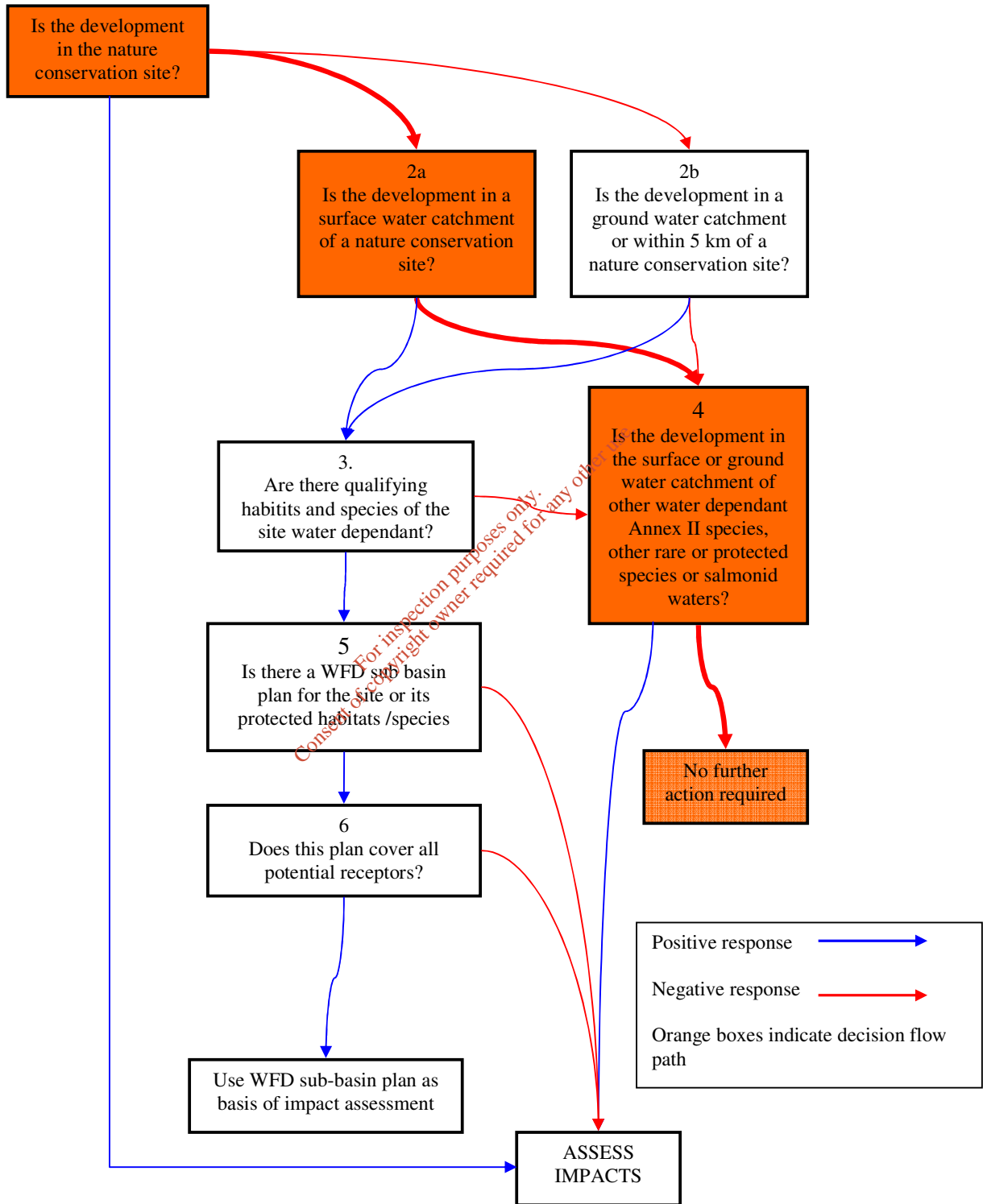
