Westland Horticulture Ltd. has revived one historical prosecution in accordance with Section 171.1 (b) of the Fisheries Consolidation Act, 1959 as amended by the Fisheries Amended Act,1962, the Fisheries Act, 1980 and the Local Government (Water Pollution) Amended Act 1990 to 1 Count only i.e. "permit to fall" into the waters wit. a water course of the Inny River deleterious matter to wit. peat silt effluent- on the 8th of November, 2002 at Mayne, Electoral Division of Coole in the County of Westmeath.

While Westland were prosecuted in respect of the above. The circumstances that surrounded this event should be noted, firstly the site had been newly purchased by Westland, and the event occurred during a period of heavy rainfall.

There have been no offences committed under the Waste Management Act 1996, or the Air Pollution Act 1987.

Mark Hamill will be responsible for Environmental & Peat Harvesting operational responsibilities and Jarlath Quinn Financial responsibilities. Neither the relevant persons have have ever been convicted under the PoE Act, the Waste Management Act 1996, the Local Government (Water pollution) Acts 1977 and 1990 or the Air Pollution Act 1987 and are considered fit & proper persons nominees.
