I have a couple of questions on the application for review of the licence W0011-02.

I wonder can you please state what is the status of the 2009 Feasibility Study for Management and Remediation of the Avoca Mining Site in terms of the necessary approvals to proceed with the works? Please also state if there has been any other feedback on the scope of the remediation plan and in particular on those elements of the plan that deal

with water treatment (and particularly groundwater emanating from the general area of the landfill).

Please also provide any updated readings from your new leachate monitoring borehole L10/01. I think I'm correct in noting the initial reading for leachate was a depth of something less than 2 metres.

Please tell me if any further leachate monitoring boreholes have been drilled in the interim?
