TECHNICAL AMENDMENT B TO WASTE LICENCE

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. W0044-02 granted on 2 May 2003 and amended on 8 May 2009, as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Acts 1996 to 2010.

Technical Amendment

In pursuance of the powers conferred on it by Section 42B(1)(c) of the Waste Management Acts 1996 to 2010, the Agency amends Licence Reg. No. W0044-02, granted to Padraig Thornton Waste Disposal Limited, Thorntons Recycling Centre, Killeen Road, Ballyfermot, Dublin 10.

Henceforth, the licence shall be read in conjunction with Amendment A issued on 8 May 2009 and the amendments set out below.

This technical amendment is limited to the following:

Part I Activities Licensed

Condition 5.3

Condition 5.9.1

Amendments

Part I Activities Licensed

Licensed Waste Disposal Activities, in accordance with the Third Schedule of the Waste Management Act 1996

Class 11. Blending or mixture prior to submission to any activity referred to in a preceding paragraph of this Schedule.

This activity is limited to the bulking up of domestic, commercial and industrial wastes at the transfer station prior to transfer to disposal facilities and the sorting of construction and demolition wastes at the facility.

Class 12. Repackaging prior to submission to any activity referred to in a preceding paragraph of this Schedule.

This activity is limited to baling and compacting of municipal waste and shredding of construction and demolition waste.

Class 13. Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned was produced.

This activity is limited to the temporary storage of waste prior to bulking and transfer to an appropriate facility.

Licensed Waste Recovery Activities, in accordance with the Fourth Schedule of the Waste Management Act 1996

Class 2. Recycling or reclamation of organic substances which are not used as solvents (including composting and other biological transformation processes):

This activity is limited to cardboard, wood and municipal waste recovery and recycling.

Class 3. Recycling or reclamation of metals and metal compounds:

This activity is limited to steel, metal and beverage container recycling.

Class 4. Recycling or reclamation of other inorganic materials:

This activity is limited to recycling and recovery of construction and demolition waste, municipal waste and plastics.

Class 8. Oil re-refining or other re-uses of oil:

This activity is limited to refining of waste vegetable oil to bio-diesel fuel for use by Padraig Thornton Waste Disposal Limited vehicles.

Class 9. Use of any waste principally as a fuel or other means to generate energy:

This activity is limited to the use of refined waste vegetable oil as bio-diesel.

Class 11. Use of waste obtained from any activity referred to in a preceding paragraph of this Schedule:

This activity is limited to the use of refined waste vegetable oil as bio-diesel.

Class 13. Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced:

This activity is limited to the temporary storage of waste prior to recovery, recycling or reclamation.

Delete Part I Activities Licensed of the existing licence and replace with the above Part I Activities Licensed.

Conditions of Licence

- 5.3 All putrescible and odour-forming waste shall be removed from the facility within 48 hours of its arrival at the facility. At bank holiday weekends, such waste shall be removed from the facility within 72 hours of its arrival at the facility.
- 5.9.1 Construction and demolition waste shall be accepted and handled in Building 2 and Building 5. Wastes which are capable of being recovered shall be separated and stored temporarily indoors prior to being subjected to other recovery activities at the facility or transport off-site.

Delete conditions 5.3 and 5.9.1 of the existing licence and replace with the above conditions.

This technical amendment shall be cited as Amendment B (in pursuance of Section 42B(1) of the Waste Management Acts 1996 to 2010) to Waste Licence Register No.W0044-02.
